### Entry fee components:

The entry fee consists the organisation of the event, accreditation cards, access ID, parking permits, information and program folder, giveaways and souvenirs. **All fees must be received by the Organisers at March 31st, 2015**. This also includes payment for banquet etc. (acc. to Final Entry Form). For entry fees received later than March 31st, 2015, participants must pay an additional fee of 15%. The entry fee paid at the contest site will be increased by 25% and must be paid in cash at the contest office.

# 1.5 frequencies

2.4 GHz transmitters have to fulfil European Standard EN 300328. The maximum equivalent emission power EIRP is 100mW peak. The transmitter must be CE marked and bear the declaration of conformity. Other transmitters for model aircraft are accepted on demand and must use in Austria authorized frequencies:

35 MHz band channel 61 - 80, 260, 281, 282 40 MHz band channel 50-53

Other frequencies are not permitted !



# chapter 4 - where



### Austria

Austria is located in the center of Europe and was first mentioned in the year 996AD and encompasses both the Eastern Alps, which cover almost two-thirds of its territory, and the Danube region. The surface area is 83,858 km<sup>2</sup> (32,378 square miles). Because of its location, the country has always been a crossroad between the great economic and cultural regions of Europe. It is bordered by the Czech Republic and Germany to the north, Hungary and Slovakia to the east, Slovenia and Italy to the south, and Switzerland and Liechtenstein to the west.

### Climate

This European heartland is home to a wide variety of landscapes, climates and flora. Austria's landscapes include major and minor mountain ranges, hills and plains. The foothills of the Alps and Carpathian Mountains, the Vienna Basin and parts of Austria's share of the Pannonian plains in the east are the most important areas of settlement and economic activity. The country's highest mountain is the Grossglockner (3,797m or 12,457 feet), and the most important river is the Danube, which flows across Austria for some 350 km (210 miles).

Austria lies in a temperate climatic zone with the influence of a moderate Atlantic climate felt more strongly in the west and northwest while the east reflects a more continental climate. Precipitation levels drop significantly from west to east and rise with altitude. The diversity of topographical and climatic conditions results in a wide variety of flora and fauna. Austria is one of Europe's most heavily wooded countries (47% of total area).

### Language

The official language in Austria is German Official event languages: English and German

### Currency

The unit of currency is the EURO which is divided into 100 cents. There is no limit on the amount of money that may be taken into Austria. If you are carrying cash or equivalent means of payment in the amount of EUR 10,000 or more, these must be declared to customs.

Most hotels, restaurants and businesses accept credit cards (American Express, Visa, Eurocard/MasterCard and Diners Club). All common currencies can be exchanged at banks, post offices, at airports, in bigger hotels, tourist offices and other currency exchange locales.

A network of ATM machines, most of which allow cash advances on credit cards, can be found across the entire country. Currency exchange machines are available in some cities. There is no restriction on cash amounts being imported to or exported from Austria.

### Electricity

Austria uses 220 Volts, AC at 50 cycles/seconds. The plugs in use are two-pin round. Some appliances will not function well, even if equipped with an adapter.

### Carinthia



Carinthia is the most southerly province of Austria and was founded in the year 976.

The first inhabitants of the country were Celts in the first century AD the Romans conquered the country. In 1335, Carinthia became part of the Habsburgs empire and joined to the Duchy of Austrian Circle in the year 1512.

Carinthia borders Slovenia and Italy, the climate is almost Mediterranean. The country is a popular tourist destination because of its mountains and its numerous warm lakes.

The capital, Klagenfurt is on the east bank of Lake Wörthersee. Klagenfurt was already established by the 12th century. The town's landmark is a dragon, a kind of dragon that once threatened and killed peasants.



The Klopeinersee region is located approx. 20km east of the Carinthia's capital Klagenfurt. The region includes the villages St. Kanzian, Seelach, Buchbrunn, Grabeldorf, Obersammersdorf and Srejach.

First marks of settlement were found on the southern water's edge of Lake Klopeinersee that have been dated to the year 900 BC.

The political commune of St. Kanzian was founded in the year 1866. The Klopeinersee region currently has a population of approx. 4300 inhabitants and is located at three lakes and at the biggest river of Carinthia.



- F3C: one F3C Team Manager maximum 4 F3C competitors where at least one must be a junior
- F3N: one F3N Team Manager maximum 4 F3N competitors where at least one must be a junior
- F3CN: unlimited number of Helper /Caller/Mechanic/ Supporter

### **Direct qualification**

The reigning World Champion has the right (subject to the approval of his NAC (National Airsports Control) to participate in the next World Championships in that category regardless of whether he qualifies for the national team or not. If he is not a member of the national team, his score will not be considered in the team results. /acc. to B.3.5 and B.3.4 SC ABR 2015



- EU citizens must bring the European Health Insurance Card (EHIC) issued by their social security system, in order to be covered by the host country's healthsystem. Citizens from outside the EU should provide their own health insurance to cover accident and illness.

# GENERAL INFORMATION ON VISAS

Visa applications have to be lodged at the Austrian embassy or consulate in your country of residence.

THE UNIFORM «SCHENGEN» VISA

- The uniform visa is a short stay visa (e.g. tourism, private visits or short business) for all Schengen countries (Belgium, Denmark, Germany, Estonia, Finland, France, Greece, Iceland, Italy, Latvia, Lithuania, Luxembourg, Malta, Netherlands, Norway, Austria, Poland, Portugal, Sweden, Switzerland, Slovakia, Slovenia, Spain, Czech Republic, Hungary).
- Third country nationals who want to travel to the Schengen countries for tourism, private visits or business can apply for short stay visas (one up to ninety days), which is valid for all Schengen countries. In very special cases visas with a longer validity (for stays up to 90 days every six months) can be issued (please refer to your competent embassy or consulate),
- The application itself does not automatically give the right to travel or to get a visa. Visas can only be issued if all necessary preconditions are met.

• Applicants have to present at least the documents mentioned below according to the type of visa applied for.

According to each individual case the competent embassy or consulate can ask for further documentation.

APPLICATIONS FOR SHORT STAY VISAS (TOURISM - PRIVATE VISITS - BUSINESS) SHOULD BE PRESENTED PERSONALLY. THE FOLLOWING DOCUMENTS SHOULD BE PROVIDED:

- Application form (completely filled out and signed personally or in case of minors by the relevant legal guardian).
- A recent photo (according to ICAO standards)
- Passport (valid at least 3 months after the expiry of the visa with at least 2 empty pages, passport not older than 10 years)
- At selected embassies (please see your embassy website), biometric identifiers (10 fingerprints taken flat and collected digitally) of each applicant shall be collected
- proof of legal stay (if the application is not presented in the country of origin)
- Consular fees:
  - Short stay visa: € 60,-
  - Long stay visa: € 100,-

in EURO or local currency. For detailed information or exceptions please visit the website of the embassy or consulate concerned, read the information boards in front of the embassy or obtain the information by telephone.

- Travel medical insurance valid for the Schengen states for the intended stay proving that all risks are covered (minimum coverage € 30.000,- in original + one copy)
- Means of transport (reservation of travel voucher or proof of private transport)
- Proof of income / documentation of paid activity (if applicable). For detailed information or exceptions please visit the website of the embassy or consulate concerned, read the information boards in front of the embassy or obtain the information by telephone.
- Proof of financial means or electronic letter of guarantee (Elektronische Verpflichtungserklärung - the person inviting the applicant should make a declaration of guarantee at the local office of the "Fremdenpolizei" ( alien's police) which informs the competent embassy or consulate accordingly)
- Justification concerning the stay in Austria

An application based on a private invitation:

- Original invitation (unless an original electronic letter of guarantee was made at the alien's police).

An application based on a business invitation:

- Official invitation letter (originals only unless an original electronic letter of guarantee was made at the alien's police)

An application without invitation:

- Proof of accommodation

APPLICATIONS FOR LONG STAY VISAS:

(E.g. students, minors in school, marriage, paid activities or other) are under special administrative procedures depending on the purpose of stay.

For detailed information or exceptions please contact the website of the embassy or consulate concerned (and if not possible), the information boards in front of the embassy.

**IMPORTANT NOTES:** 

- The uniform visa does not allow paid activities or stays exceeding 3 months in Austria. Therefore please apply for Long stay visa up to 6 months (NOT extendable or renewable) or a residence permit.
- You are kindly asked to present your application at least three weeks before the intended travel.
- The consular fees have to be paid when lodging the application; they are not reimbursed in case of refusal.
- All points of the visa application form have to be filled out completely and correct.
- Documents missing may cause inadmissibility of the application or delay the application.
